**All consignors are required to sign an affidavit that all livestock consigned to the  
Springville Feeder Auction is of USA origin.**

1. IT IS REQUIRED THAT EACH CONSIGNOR OWN ONE SHARE OF STOCK-PAR VALUE \$5.00
2. **Consignment fee \$18.00 per head for Feeder Calf Sale,**
3. Three dollars (\$3.00) per head must be turned in with consignment. Consignment will not be considered binding in the Association unless the \$3.00 per head is paid.
4. **Consignment fee forfeited if cattle are not delivered.**
5. Number of head delivered not to be more than 110% of number consigned.
6. Each sale limited to the first 1000 head **paid** consignment.
7. All cattle to be free of apparent disease.
8. All cattle remain the property of the consignor until sold.
9. All cattle must have been **ON THE CONSIGNOR FARM 120 DAYS OR MORE PRIOR TO SALE.**
10. Consignors may select **ON FARM, UNIFORM pens of 10 or more head of cattle to sell direct.**
11. **NO BULLS ACCEPTED AT THE OCTOBER 4<sup>th</sup> SALE.**
12. Any consignor who bids on his own direct consigned livestock or has someone (relative, employee or any other person) bid on his livestock with the purpose of increasing the final sale price, or who brings cattle which have not been on his farm 120 days will run the risk of forfeiting his right to consign livestock in future sales. All cattle consigned may be subject to an on farm spot check.
13. Consignors will be charged \$2.50 per head for insurance coverage under a Hartford Insurance Policy.
14. \$1.00 per head will be deducted for National Beef Promotion & Research Program Investment Checkoff.
15. Each consignor limited to 200 head of cattle in any one sale.
16. **No cattle accepted after 4:00 P.M. Thursday.**
17. The Association reserves the right to reject cattle not meeting above requirements.
18. Consignors agree that any liens upon livestock hereby consigned will be fully satisfied and further agree to indemnify, hold blameless, and defend the Association, its officers, and directors from any claims on account of the sale of the livestock.
19. Consignor hereby agrees to leave all decisions concerning the weighing and grading of cattle and order of sale to the management of the Association.
20. I have read the above rules and regulations and hereby agree to abide by them.
21. Office hours prior to sale 9:00am to 3:00pm Monday.

23. **Any disputes or errors must be reported within 14 days of the sale date.**
