**All consignors are required to sign an affidavit that all livestock consigned to the  
Springville Feeder Auction is of USA origin.**

1. IT IS REQUIRED THAT EACH CONSIGNOR OWN ONE SHARE OF STOCK-PAR VALUE \$5.00
2. **Consignment fee is 3% of final sale price with a \$25.00 per head minimum fee.**
3. **Ten dollars (\$10.00) per head MUST BE TURNED IN WITH PRE-CONSIGNMENT.** Consignment will not be considered binding in the Association unless the \$10.00 per head is paid.  
**\*PRE-CONSIGNMENT REQUIRED BY OCTOBER 5<sup>th</sup>.**
4. Consignment fee forfeited if cattle are not delivered.
5. All cattle to be free of apparent disease.
6. All cattle remain the property of the consignor until sold.
7. All cattle must be consigned before the deadlines as set by the Board of Directors.
8. All cattle must have been **ON THE CONSIGNORS FARM 120 DAYS OR MORE PRIOR TO SALE.**
9. **No heifers of dairy breeding allowed. NO BULLS ALLOWED.**
10. Cattle must be identified with state approved permanent ID and a large number tag.
11. Cattle will arrive at the Feeder Auction with a health paper and a certificate stating month of pregnancy signed by their Veterinarian. Cows can not be over 8 yrs. of age.  
**\*ALL VET WORK WILL BE DONE ON CONSIGNOR'S FARM PRIOR TO DELIVERY.**
12. Cattle are to be delivered between 7:00 – 10:00 AM EST on October 17<sup>th</sup> .  
**\*Cattle delivered after 10:00 AM EST will not be accepted.**
13. There will be no commingling of cattle.
14. Any consignor who bids on his own direct consigned livestock or has someone (relative, employee or any other person) bid on his livestock with the purpose of increasing the final sale price, or who brings cattle which have not been on his farm 120 days will run the risk of forfeiting his right to consign livestock in future sales. All cattle consigned may be subject to an on farm spot check.
15. Consignors will be charged **\$2.50** per head for insurance coverage under a Hartford Insurance Policy.
16. **\$1.00** per head will be deducted for National Beef Promotion & Research Program Investment Checkoff.
17. The Association reserves the right to reject cattle not meeting above requirements.
18. Consignors agree that any liens upon livestock hereby consigned will be fully satisfied and further agree to indemnify, hold blameless, and defend the Association, its officers, and directors from any claims on account of the sale of the livestock.
19. Consignor hereby agrees to leave **all** decisions concerning the weighing and grading of cattle and order of sale to the management of the Association. **Lot size not to exceed 10 head.**
20. **Springville Feeder Auction is acting only as an agent and does not guarantee the accuracy of the breed or pregnancy status information.**
21. **Consignors may set a floor price for this sale. If livestock does not meet the set floor price, the consignor will still pay 3% of the floor price with a \$25.00 minimum.**
22. **Any disputes or errors must be reported within 14 days of the sale date.**
23. Office hours are Mondays from 9:00 am – 3:00 pm EST.
